# Request for Qualifications Architectural Services

#### Overview

The City of Falfurrias (City) is soliciting responses from firms with professional qualifications and experience in providing architectural services. Statements of qualifications will be accepted from individuals, firms, or groups of firms who can demonstrate they have the resources, experience, and qualifications to provide a range of architectural services. It is the City's intent to obtain architectural services to design an approximate 10,000 square foot advanced business incubation facility funded by the United States Department of Agriculture's (USDA) Rural Business Development Grant (RBDG).

#### **Background**

The City of Falfurrias is seeking preliminary and final design plans and specifications for a 10,000 square foot building located at 118 W. Rice St, Falfurrias, TX 78355 (Exhibit A). The site is conjoined with the City of Falfurrias' existing Falfurrias Economic Development Accelerator (FEDA) building located at 120 W Rice St, Falfurrias, TX 78355, and will serve as an extension of this facility. The survey attached in Exhibit B displays the conjoined property, where although not separated by an interior wall, the rightmost 10,000 square feet of the building will be the prospective rehabilitation site. The location is an existing facility (previously a Bealls) that requires rehabilitation to develop an advanced business incubation system which will consist of a large store front business area at about 50% of the building's square footage and office space area at the remaining 50% of the building's square footage. The facility's rehabilitation plans will require interior construction, interior and exterior design, electrical, HVAC, plumbing, and communication components. Grant funds are expected to provide funding to rehabilitate the 10,000 square foot section of the facility, including its façade and parking space.

#### **Scope of Services**

The architectural contract will encompass all project-related architectural services to the City of Falfurrias, including but not limited to the following:

- Preliminary and final design plans and specifications;
- Preparation of specifications for required sub-contractor bids; and
- Other architectural services.

#### **Response Content**

Responses must adhere to the requirements outlined in this section. The original statement of qualifications and each subsequent copy must be submitted on paper, properly bound, and appropriately labeled in the following order:

- 1. <u>Introduction:</u> Provide a cover letter and introduction including the name and address of the firm with the name, address, telephone and fax numbers, and e-mail address of the contact person who will be authorized to make representations for the organization. An Executive Summary shall be provided with an overview of the statement of qualifications, its highlights, and the approach to architectural services.
- 2. <u>Service Approach:</u> A general description of the firm's approach to architectural services and a detailed task plan that addresses the scope of services.
- 3. Scope of Work and Schedule: Discuss each task outlined in the "Scope of Work" section above.
- 4. Qualifications: Describe the firm's resources, experience and capabilities as follows:
  - a. Provide an outline of the firm's background, qualifications, and ability to perform the scope of services required.
  - b. Provide a list and/or organizational chart of the firm to identify the person(s) who will be primarily responsible for contact with the City.
  - c. Identify all key personnel, relevant qualifications and experience, and their level of effort toward completing all needed tasks.
- 5. Provide a brief outline of the firm's current workload, staffing and ability to meet the schedule and deadlines.
- 6. <u>References:</u> Identify at least two (2) similar clients that the firm currently provides service to, preferably municipal governments in Texas. Each project listed shall include the name of the agency, project manager, phone number, and description of work performed. Past City architectural services may also be submitted for consideration.
- 7. <u>Additional Data:</u> This section will be limited to five (5) pages. Responses may include any other information that is deemed essential to the evaluation of the statement of qualifications.
- 8. Summary of Insurance Coverage
- 9. Completed Conflict of Interest Questionnaire
- 10. Completed Form 1295- Certificate of Interested Parties

#### **Review and Selection Procedure**

The Selection Committee will evaluate each statement of qualifications and select an architectural service provider. The following evaluation criteria and their respective weights will be used in selecting an architectural service provider:

Qualifications	20
Service approach and methodology	30
Knowledge of local issues in the City of Falfurrias and the surrounding region	10
References: Two (2) required	10
Knowledge of applicable local, state and federal regulations including but not limited to those regarding architecture and building codes.	10

The City of Falfurrias reserves the right to reject any and all responses and to waive any informality in responses received.

#### **Insurance Requirements:**

For the duration of the appointment, the service provider must maintain Commercial General Liability insurance with limits of not less than \$1,000,000 per occurrence and \$2,000,000 aggregate, Professional Liability Insurance with limits of not less than \$1,000,000 per occurrence if available to a professional engaged in consultant's regular course of business, Automobile Liability insurance with a minimum limit of \$1,000,000 per accident, and Workers Compensation Insurance as required by the State of Texas.

Service Provider shall maintain liability insurance in an amount of not less than \$1,000,000 per occurrence, naming the City as an additional insured, covering any such unauthorized disclosure of Protected Information caused by a defect or failure of the Software or any electronic communication system maintained or controlled by Service Provider.

The City reserves the right to establish that these insurance requirements be met and complied with prior to any contractual agreement is entered into. The cost of such insurance is the service provider's responsibility. Failure to comply could result in non-award of the contract.




