The deadline to submit bids is 9:00 A.M. on Thursday, September 21, 2023, at which time said proposals will be publicly opened at the Falfurrias Economic Development Accelerator (FEDA)/City Hall located at 120 W. Rice St., Falfurrias, Texas 78355.

Said proposals will be submitted to the City of Falfurrias Mayor and Council at the next Council meeting succeeding proposal opening, scheduled for 6:30 p.m. on Monday, October 2, 2023, at the Falfurrias Economic Development Accelerator (FEDA)/City Hall located at 120 W. Rice St., Falfurrias, Texas 78355, for the purpose of selecting an interested proposer. Proposers are invited to be present.

The City of Falfurrias reserves the right to reject any or all proposals, to waive technicalities or formalities, and to accept the proposal deemed to be the lowest responsible bid or the bid which provides goods or services at the best value for the City of Falfurrias.

General Background

The City of Falfurrias Utilities Department is soliciting interested parties to submit their proposal to haul away approximately 24,000 cubic feet (890 cubic yards) of excavation soils. The material to be removed consists of dried excavated local soils with small amounts of pavement aggregate and concrete. No hazardous or industrial materials are included in the soil. All visible concrete and metal materials have been removed and separated and are available as well. The Utilities Department will provide the front loader and operator to load materials.

A proposal may not be considered if any information required by this proposal is not provided.

The proposal must include the following items:

- The time needed by the proposer to:
 - Begin picking up material from the approval of the Proposer by the City of Falfurrias.
 - Complete the pickup of said material.
- A statement of guarantee that all materials, including soil, as well as the extracted pavement aggregate, concrete and metal materials will be removed by the Proposer.
- The ability to collect material, where the Proposer must highlight the availability of dump trucks or trailers needed to remove soils within a few days of operations.

The selected proposer will sign a form indemnifying the City for all liabilities as to the content of the soil and its use, as well as any damage that may occur during the loading of the soils. The selected proposer will understand that the staff of the Utilities Department must attend emergencies jobs and therefore delays or cancellations of dates and times loading of the soil may occur.
