The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for City of Falfurrias from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that City of Falfurrias may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that City of Falfurrias is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 9, 2024 AT 5:30 pm AT FEDA Building 120 W. Rice St. Falfurrias, Texas 78355.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, City of Falfurrias is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the City of Falfurrias of City of Falfurrias at their offices or by attending the public hearing mentioned above.
